## CONTRIBUTORS/COLLABORATEURS

**T.W. ACHESON** is the chair of the Department of History at the University of New Brunswick; a former president of the Canadian Historical Association, he is the author of influential studies in regional history, including *Saint John: The Making of a Colonial Urban Community* (Toronto, 1985). **LAURIE C.C. STANLEY-BLACKWELL** teaches history at St. Francis Xavier University; she has published *The Well-Watered Garden: The Presbyterian Church in Cape Breton, 1798-1860* (Sydney, 1983). **JERRY N. PITTMAN** is a graduate of Carleton University and the University of New Brunswick; he is currently preparing a doctoral thesis on the history of science and religion in the 19th century. **SUZANNE MORTON** teaches history at McGill University; her earlier work has appeared in *Acadiensis* and *Labour/Le Travail* and she is currently co-editing a book for Acadiensis Press on the history of women in the Maritimes. **JUDITH FINGARD** is Dean of Graduate Studies at Dalhousie University; since the appearance of her last article in *Acadiensis* she has published *Jack in Port: Sailortowns of Eastern Canada* (Toronto, 1982) and *The Dark Side of Life in Victorian Halifax* (Porter's Lake, N.S., 1989); she also contributed the chapter on the 1880s to E.R. Forbes and D.A. Muise, eds., *The Atlantic Provinces in Confederation* (Toronto/Fredericton, 1993). **IAN McKAY** teaches history at Queen's University; he has recently published, with Scott Milsom, an anthology entitled *Toward a New Maritimes: A Selection from Ten Years of New Maritimes* (Charlottetown, 1992); he contributed the chapter on the 1910s to *The Atlantic Provinces in Confederation*. **PHILLIP J. WOOD** is a former member of the political science department at St. Francis Xavier University and now teaches at Queen's University; he is the author of *Southern Capitalism: The Political Economy of North Carolina, 1880-1980* (Durham, N.C., 1986). **STEVEN MAYNARD** is completing a doctoral thesis at Queen's University, where he teaches working-class and social history; his earlier work has appeared in *Labour/Le Travail* and *New Maritimes*. **BLAIR NEATBY** is Professor of History, Carleton University; he is the author of classic studies in Canadian political history, including *The Politics of Chaos: Canada in the 1930s* (Toronto, 1972). **JOHN EDWARD BELLIVEAU** is a former national journalist and foreign correspondent for the *Toronto Star* and a political advisor to three Maritime premiers; he is the author of several books of popular history, including *Little Louis and the Giant K.C.* (Hantsport, 1980) and *The Monctonians*, 2 volumes (Hantsport, 1981, 1982). The distinguished political scientist, **J. MURRAY BECK**, is professor emeritus, Dalhousie University; his most recent books include the two-volume biography, *Joseph Howe* (Montreal/Kingston, 1981, 1982), and the two-volume study, *The Politics of Nova Scotia* (Tantallon, N.S., 1985). **DONALD A. WRIGHT** completed an M.A. in Canadian history at McGill University; he is a contributor to *The McCord Family: A Passionate Vision* (Montreal/Kingston, 1992) and has also written for *The Anti-Poverty News* (Fredericton).
