
# Small but Significant Errata/Typos in the Paper "The Distinction Between False Dilemma and False Disjunctive Syllogism"

In the paper *The Distinction Between False Dilemma and False Disjunctive Syllogism*, by Taeda Tomić, *Informal Logic* vol. 41, No 4 (2021), pp. 607-639, there are typos in Figure 12, on page 630. In the last row of the figure, direct after "Thus", the connective should be disjunction instead of the conjunction in the conclusion (written after the rightwards double arrow); and the propositional letter "D", as well as the entire disjunctive sequence should also be included. It should be:  $C \vee D \vee E \vee F \vee ...$  Fn; instead of:  $C \wedge E \wedge F$ .

Thus the figure 12 without the typos should be:



Opponent: Yes,  $A \lor B$ ,  $\neg B \Rightarrow A$ .

However, it is also true and relevant that  $A \lor B \lor C \lor D \lor E \lor F \lor \ldots$  Fn, which also shows that  $\neg A.$ 

Thus,

 $A \lor B \lor [C \lor D \lor E \lor F \lor \dots Fn], \neg B, [\neg A] \Rightarrow C \lor D \lor E \lor F \lor \dots Fn.$
