## EDITOR'S NOTE

OVER THE SUMMER we received welcome news about two of our 1993 articles. Joan Sangster's "The Softball Solution: Female Workers, Male Managers and the Operation of Paternalism at Westclox, 1923-1960," *Labour/Le Travail*, 32 (Fall 1993), 167-99, received two important awards. First, Joan received the prestigious Riddell Award of the Ontario Historical Society in early May. Then in June the Canadian Historical Association presented the Hilda Neatby Prize to her in Calgary. In addition, the Forest History Society awarded Richard A. Rajala its Theodore C. Blegen Award for his "The Forest as Factory: Technological Change and Worker Control in the West Coast Logging Industry, 1880-1930," *Labour/Le Travail*, 32 (Fall 1993), 73-104. We congratulate Joan and Richard on their well-deserved prizes.

In addition, we also extend our congratulations to editorial board members Bettina Bradbury and (again) to Joan Sangster. Bettina's *Working Families: Age, Gender and Daily Survival in Industrializing Montreal* (Toronto: McClelland and Stewart, 1993) won the Macdonald Prize of the Canadian Historical Association for best monograph in Canadian history. Meanwhile, Joan's article on "'Pardon Tales' from Magistrate's Court: Women, Crime and the Court in Peterborough County, 1920-1950," received the *Canadian Historical Review's* best article award for 1993.

On a less proud note, we would also like to correct a slight error in Ellen Scheinberg's article in *Labour/Le Travail*, 33 (Spring 1994). Lines 9-10, paragraph two, page 153 should read:

"While all three scholars viewed these changes as having a permanent and positive effect in American women's role in society ...."

AU COURS DE L'ÉTÉ nous avons reçu de bonnes nouvelles concernant deux articles parus dans la revue en 1993. L'article de Joan Sangster, "The Softball Solution: Female Workers, Male Managers and the Operation of Paternalism at Westclox, 1923-60," *Labour/Le Travail*, 32 (automne 1993), 167-99, a reçu deux prix importants. Joan s'est vu attribuer au début du mois de mai le prestigieux prix Riddell de la Ontario Historical Society. Puis, en juin, la Société historique du Canada lui présenta le prix Hilda Neatby. De plus, la Forest History Society a accordée à Richard A. Rajala le prix Theodore C. Nous voulons également féliciter les membres du comité de rédaction Bettina Bradbury et (une fois du plus) Joan Sangster. Le livre de Bettina, *Working Families: Age, Gender and Daily Survival in Industrializing Montreal* (Toronto: McClelland and Stewart, 1993), a remporté le prix Macdonald de la Société historique du Canada, décerné à la meilleure monographie en histoire canadienne. Sur les entrefaites, le texte de Joan, "«Pardon Tales» from Magistrate's Court: Women, Crime and the Court in Peterborough, County, 1920-1950," a reçu le prix de la *Canadian Historical Review* pour le meilleur article paru en 1993.
