### Preface/Préface

This bibliography will appear annually in each October issue of the *Urban History Review*. It is organized to follow the categories and format of A.F.J. Artibise and G.A. Stelter, *Canada's Urban Past: A Bibliography to 1980 and Guide to Canadian Urban Studies* (Vancouver: University of British Columbia Press, 1981).

The present list consists mainly of publications in the years 1979 to 1981, but items in the *Canada's Urban Past* bibliography are not included here. While the emphasis is on writings about urban Canada, some general works and statements which offer analogies, approaches and methods useful for Canadian studies have been cited.

Theses with a date of "c. 1980" were listed in the *Register of Post-Graduate Dissertations*, No. 16 (1981) compiled by the Canadian Historical Association. Users are advised that the thesis titles given here and in the Register may be slightly altered in the final, approved versions of the theses.

Chaque année, le numéro d'octobre de la *Revue d'histoire urbaine* contiendra une bibliographie conçue sur le modèle de A.F.J. Artibise et G.A. Stelter, *Canada's Urban Past: A Bibliography to 1980 and Guide to Canadian Urban Studies* (Vancouver: University of British Columbia Press, 1981). Les titres y seront classés selon les mêmes catégories.

La présente liste comprend principalement des publications des années 1979 à 1981, mais ne comprend pas les titres qui figurent dans *Canada's Urban Past*.
