The Anglican Church in the Ecclesiastical Province of Canada will be the theme of a Church History Conference, July 07 – 09, 1993 in Halifax. The Institute of Urban Studies has launched a new academic journal, the *Canadian Journal of Urban Research (CJUR)*. The journal will be published twice yearly, in June and December. The first issue appeared in June 1992. Publication of the journal is assisted by a grant from the Social Sciences and

Humanities Research Council of Canada. The Principal Editor is Mary Anne Beavis, Acting Director, Institute of Urban Studies, The University of Winnipeg.

CJUR is a multidisciplinary, scholarly journal dedicated to publishing refereed, academic articles that address a wide range of issues relevant to the field of Urban Studies, e.g.:

- urban policy
- Urban Studies theory and methods
- urban society and culture
- urban government/politics
- quality of urban life
- urban housing
- urban environment/biology
- urban health

CJUR is committed to publishing manuscripts from a variety of ideological, disciplinary and methodological perspectives, with emphasis on contribution to the field of Urban Studies. The journal publishes articles of broad, general interest as well as more narrowly technical material. Reviewers consider the following criteria in evaluating manuscripts: the substantive contribution to the field of Urban Studies; the interest of the material to the readership (primarily Canadian academics in Urban Studies and cognate fields); the quality and clarity of exposition of the submission. The journal also publishes critical notes and reviews of books. Manuscripts are reviewed by academics from across Canada in a wide range of disciplines relevant to urban research. Remembrance Day Ceremony at the Strachan Avenue Military Cemetery, West of Historic Fort York, Toronto, Ontario, Wednesday, November 11, 1992

The Toronto Historical Board and the municipal chapter of the Imperial Order of the Daughters of the Empire (IODE), present a Remembrance Day Service honouring Canada's war dead at the Strachan Avenue Military Cemetery, west of Historic Fort York, on Wednesday, November 11, 1992 at 10:45 a.m.

A processional to the cemetery will begin at 10:40 a.m. from the entrance to Historic Fort York. The ceremony will include costumed-military staff from Fort York, standard and wreath bearers of the IODE, and clergy.

The Strachan Avenue Military Cemetery was the third burial site for troops and their families garrisoned at Fort York from 1860 to 1911. Public Remembrance Day ceremonies have been held at this historically important site since 1952.

The prime goal of the Urban History Review/Revue d'histoire urbaine is to be a vehicle for the exchange of information, theories, and techniques relating to the development of urban communities over time. The UHR/RHU is concerned with the historical evolution of urban Canada in a broad sense and welcomes material from all disciplines and on topics ranging from early Canadian history to contemporary concerns over the evolution of urban policy. We wish to make available information about current research on the development of Canadian towns and cities: what scholars are discovering; what topics they are researching; what topics need to be added to our research agendas; how research can be best carried out; and what sort of research materials are available to accomplish it. One of the key aims of the UHR/RHU is to bring together the various disciplinary perspectives that exist in the broad field of urban studies. As well, the UHR/RHU is interested in publishing non-Canadian material when it deals with comparative, methodological or historiographical issues or topics.

The UHR/RHU is a bilingual, refereed journal. Articles and other materials should be submitted in either French or English. Three copies of all submissions should be sent to the Urban History Review/Revue d'histoire urbaine, Becker Associates, 36 Bessemer Court, Unit 3, Concord, Ontario L4K 3C9. The UHR/RHU publishes two categories of articles; articles that range in length from 6,000 to 10,000 words and shorter papers or research notes of 1,000 to 3,000 words. From time to time, theme issues will be published. Readers' suggestions for such issues are encouraged.

The UHR/RHU also welcomes material for the Notes and Comments section, such as reports on work in progress, thesis abstracts, conference announcements, information on recent publications, comments on urban policy (past and present), and notes on archival or other sources. Suggestions for book reviews or book review essays are also invited.

La Revue d'histoire urbaine/Urban History Review a pour objectif principal de permettre des échanges sur les informations, les théories et les méthodes susceptibles de faire progresser les connaissances sur l'évolution des communautés urbaines. La RHU/UHR interesse à l'évolution historique de l'urbanisation au Canada définie dans un sens large et reçoit avec plaisir des contributions provenant de toutes les disciplines et traitant de sujets variés depuis les premières implantations urbaines jusqu'aux débats contemporains sur les politiques urbaines. Nous souhaitons diffuser un maximum d'informations relatives au développement des villes canadiennes : rendre accessibles les conclusions des chercheurs, faire le point sur l'état actuel de la recherche, cerner des sujets susceptibles d'offrir de nouvelles problématiques de recherche, nous interroger sur les moyens de mettre en oeuvre ces connaissances et inventorier les sources et instruments de travail disponibles. L'un des objectifs fondamentaux de la RHU/UHR est de mettre en relation les approches respectives des diverses disciplines oeuvrant dans le vaste domaine des études urbaines. De plus, la RHU/UHR publie de temps à autre certains travaux, d'ordre méthodologique ou théorique, portant sur des sujets extra-canadiens et pouvant servir à des fins d'études comparatives.

Les articles sont soumis à un comité d'évaluation. La RHU/UHR publie dans les deux langues officielles et les textes soumis, en anglais ou en français, doivent être expédiés en trois exemplaires à Revue d'histoire urbaine/Urban History Review, Becker Associates, 36 Bessemer Court, Unit 3, Concord, Ontario. La RHU/UHR publie deux types de textes : des articles de 6 000 à 10 000 mots et des textes plus courts ou notes de recherche de 1 000 à 3 000 mots. A l'occasion un numéro portera sur un thème particulier et la RHU/UHR sera heureuse de recevoir des suggestions à cet effet.

La RHU/UHR accepte également des textes pour la section Notes et commentaires, tels des rapports sur la progression des travaux en cours, des résumés de mémoires ou de thèses, des annonces de colloques et de congrès, des informations sur les publications récentes, des commentaires sur des questions de politique urbaine (passées ou actuelles), des notes sur les archives ou les sources. Des suggestions quant aux notes critiques ou comptes rendus d'ouvrage sont aussi appréciées.
