## Doit-on s'assurer contre les accidents d'automobile?

En assurance automobile, la garantie \$5,000/\$10,000 contre la responsabilité civile et les accidents corporels, est-elle suffisante? Assurément, affirment les plus optimistes. Avant de se prononcer, on fera bien de jeter un coup d'oeil sur la liste des indemnités accordées par les tribunaux canadiens dans les cas suivants. - \$40,000—Brooklyn Trust Company against Niagara, St. Catharines and Toronto Railway Company, Toronto, July 27, 1938; collision, car with street car, April 26, 1933.
- \$37,135—John E. Funk against Dr. E. C. Pinkerton, Vancouver, April 21, 1938; collision, August 14, 1937.
- \$25,391 — William T. Groves against Wentworth County, Hamilton, October 21, 1938; driver of car plunged through fence in disrepair, December 4, 1937.
- \$24,965—J. B. Weir against J. W. Beveridge, Montreal, October 25, 1938; collision causing severe injuries, July 23, 1937.
