This is a special issue of the *Journal of Comparative International Management* which carries six papers selected from 190 papers submitted by authors from 17 countries to the 15th International Conference on Sustainability and Competitiveness in Business (SICB) held at the Al-Zaytoonah University of Jordan (Amman, Jordan, April 18–20, 2016). The papers included in this special issue were selected by the guest editors based on the results of a double-blind review process and their own readings of the papers.
