Preface

It is beyond the intended scope of this bibliography to provide a comprehensive compilation of urban history research for the years 1987-1988. Nonetheless, one could readily argue that this compilation is a fair representative sample of the international literature for these years, and, as such, an attempt to provide at least limited bibliographical control to a burgeoning interdisciplinary literature. Since *Urban History Review* is concerned with the historical evolution of urban Canada in a broad sense, an added effort has been made to include Canadian material.

Method of Compilation

Computerized literature searches were done on: *Historical Abstracts*; *America: History and Life*; and the holdings of the Library of Congress, the most complete universal bibliography for monographs. In addition, the following material was manually searched: *Canadian Journal of Political Science*; *Canadian Review of Sociology and Anthropology*; *Plan Canada*; *Register of Post-Graduate Dissertations in Progress in History and Related Subjects*; *Urban Affairs Quarterly*; and *Urban Studies*. The bibliographical data was entered into a data base using UNESCO's Micro CDS/ISIS software which provided indexing and sorting procedures.
